Two-day event aimed to encourage young people to take part in the upcoming European Parliament elections.			
On 21 February, participants had the opportunity to learn about the European Parliament's activities and current affairs and take part in a panel discussion with Lithuanian MEPs, youth representatives and other guests.			
On 22 February, the podcasts of NOTE partners on the activities of the European Parliament were presented. The other important part of the agenda was an exchange between the project partners about the Toolkit. They also discussed the process of NOTE Podcasts' production which was ongoing at this time, as a part of this Work Package and that are published on FattoRadio's channels.

#### The main take-aways:

- The head of EP Liaison Office in Lithuania Daiva Jakaitė presented what makes the European Parliament interesting, the structure of the European Parliament and the activities of MEPs.
- It was explained where to look for more information about the European Parliament, as there is a lot of information out there and it is difficult for young people to sort out what is important.
- The LiJot initiative was presented and other insights were shared on how to contribute to young citizens' activism. Briefly, all this was summarized in a panel discussion together with MEPs, candidates for the European Parliament and the youth representatives themselves.
- The MEPs agreed that politics is a complex field, so a young person should not be forced to get involved, in other words, such involvement will come naturally with time.
- The discussion participants also shared their experiences in working with the news, and youth representatives shared their insights on instruments that are oriented to increase youth inclusion, such as posting on TikTok and other social media.
- Many valid ideas were mentioned during the discussion. One of them was that politicians should monitor youth engagement and therefore work with information that doesn't stimulate young people's attention.
- The second day of the event was dedicated to reviewing podcasts and presenting the NOTE Toolbox. From this day, the participants were able to take away more knowledge about what activities related to the EP elections were implemented by the NOTE project and what they would like to do in the future. In the podcasts, the young representatives gave an overview of the EP's social networks, which pointed out how social networks can help to attract and engage young people. Below you can see the outcomes of this session (timeframe of work and planned content of the Toolbox).
- The partners shared their experiences and challenges they encountered when working on NOTE podcasts. They once more reviewed the instructions

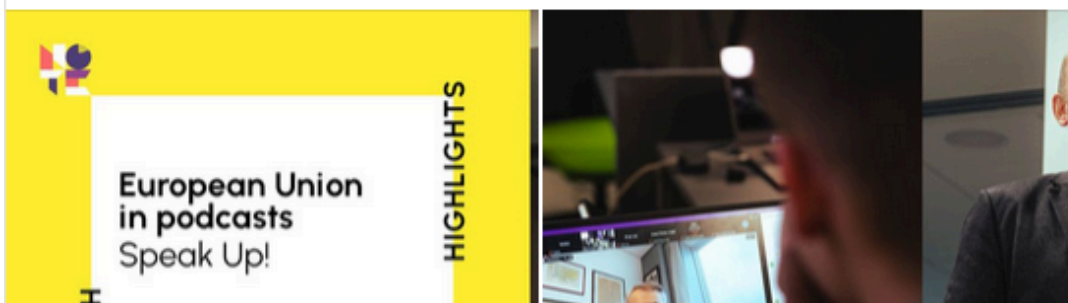

From all the feedback received, the overall rating from participants is 4-5 out of 5. Participants rated the event as good and found it informative.
