**Description of the event and its activities.**

This Work Package event was executed in four connected parts between June and October 2023, precisely on: 14.06, 19.07, 11.10 and 31.10 2023.

The aim of the events, which together constitute WP3 of the project, was to bring young people closer to European Parliamentarians and EU institutions in view of the next European Elections in 2024, to discuss participatory democracy and the European elections on the local level.

Brussels-based ECIT Foundation, the host of the WP3, requested the possibility of moving the execution of this Work Package 3 from Month 7 (July) to Month 10 (October) to better achieve its desired objectives. Taking place over separate days allowed the project participants to focus on a few topics, give them time to “digest” the information received, inform themselves and then attend the sessions in October, coinciding with one of the days of the European Week of Regions and Cities (EWRC).

**July: 19.07, 14.00-16.45**

***Tools for Boosting Citizen Engagement: Participatory Democracy & European Elections on the Local Level***

The July session consisted of modules specifically dedicated to the European elections, youth participation in the European and local campaign, knowledge of the together.eu platform, the opportunities that the European Union offers at local level through it, and to the Parliament Europe communication campaign. In this session the participants were allowed to learn about what the EU does in their area, which projects are financed with European funds and how the EU impacts their daily lives. This event consisted of two panel presentations/seminars focused on increasing citizen's engagement, mapping the context of the next European Union elections and youth participation at the local and European level.

The first part of this session involved a brief presentation from each of the speakers (5-10 minutes), followed by some questions for discussion:

- How can civil society and volunteers like VWB get involved?
- What help can they expect in terms of useful materials, networking and outreach?

This session was dedicated to how the European elections can be communicated, and how best to connect local citizens, especially young people, to the EU across the election period.

15.40 – 16.40 (CET) – Exploring how to make the European elections relevant at local level and the toolkit needed to get local people involved

For this session, each partner was asked to prepare to discuss their plans for the European Elections, with most of the time dedicated to discussion between NOTE participants and speakers on questions such as:

- What type of information is required to make the EU relevant at the local level?
- How to involve local people through street debates, games or cultural events? Going out to reach hard-to-reach groups?
- Engaging with parties and candidates through questionnaires, debates and more formal town hall meetings?
- Can the European elections provide an opportunity to experiment with local and cross-border citizen deliberations on European issues following the example of the Conference on the Future of Europe?

This session was specifically thought for NOTE partners, but also open to the general public. For instance, it was designed for actors at the local level such as municipalities but also civil society.

**October: 11.10, 14.30-16.00**

**GETTING LOCALS INVOLVED IN THE EUROPEAN ELECTIONS: Is Citizen Participation the Answer?**

The October event focused mainly on the local action of the European Union, to tie in with the theme of regions and cities of the EWRC: it talked about the involvement of young people and civil society as local actors and how they can be involved in the decision-making process. The first explored the topic of town assemblies, taking the example of the Conference on the Future of Europe and transposing the idea to the local level.

**Background briefing and questions for participants**

This political lab discussed local citizen participation in areas where there is significant EU funding as one way to achieve the objective of European electoral participation. The 2019 elections reversed a trend of declining participation. Could that average turnout of just over 50% be improved upon in the elections next June? In its communication campaigns for the elections, the European Parliament has in the past placed emphasis on supplying information on “what the EU does for you in your region”. If citizens were more aware of the level of investment from EU cohesion policy and other programmes in their community, would they not be more convinced of the relevance of the elections to their everyday life and vote? Information is important, but is it enough? There is a strong argument for going further and turning citizens from spectators to partners. There is a widespread paradox across the EU: it is often in the regions which benefit most from EU funding that the rates of abstention are highest. The 5th objective of cohesion policy 2021-2027: “A Europe closer to citizens by fostering sustainable and integrated development of all types of territories and local initiatives” also implies that there should be a high level of citizen participation.

In the run up to the elections, how to follow up the Conference on the Future of Europe and turn its experiment with citizens panels into a more permanent feature of EU policy making will be highlighted so that reforms can be put in place by the next legislature. For example, the European Parliament’s report on “Parliamentarianism, European citizenship and democracy “ (A9-0249/2023) of 14 September is advocating an online one stop shop for citizen participation and an annual European Agora for face-to-face deliberation. Similarly, “Engaging citizens in cohesion policy -DG Regio and OECD pilot project “ (OECD public governance working paper no 50) reflects similar concerns and contains a detailed set of recommendations, including the need to go further than experiment and find institutional solutions.

### **October: 31.10, 14.30-16.00**

How did Union Citizenship come about? What has been the track record? A public relations exercise or the first post-national citizenship of the modern era? Such contrasting views expressed at the time of the Maastricht Treaty have tended to converge. There has been extensive case law in the European Court and updated legislation to strengthen European rights to freedom of movement in the areas of residence rights, access to social security and recognition of qualifications. Yet many barriers still remain especially for job seekers, minorities, and low-income groups.

The 30<sup>th</sup> anniversary should be about taking the plunge and imagining how this unique transnational citizenship could become more relevant to all Europeans and strike the popular imagination.

The first session in the afternoon was part of the Work Package 3 "*Tools for boosting citizens' engagement. Participatory democracy of the NOTE* (Network of Organisations and Towns for the European elections) project, funded by the CERV programme of the EU. The partners in the project joined on-line to explain the focus of the project on street debates to involve voters in the 2024 European elections.

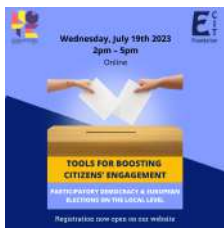
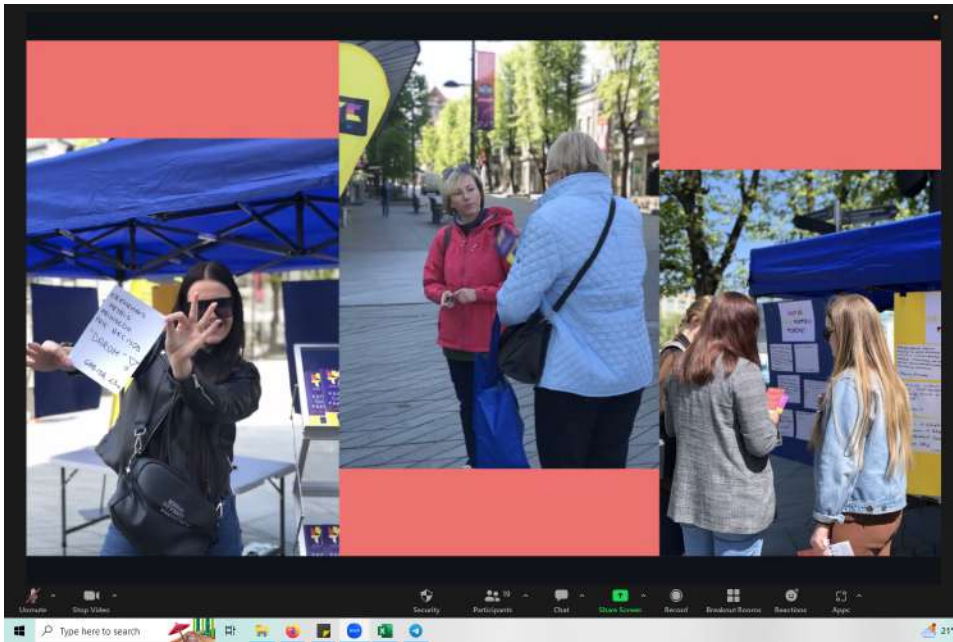
